SUBJECT: **ELECTION OF SECOND MEMBERS - LACERA BOARD OF INVESTMENTS
AND BOARD OF RETIREMENT**

On May 9, 2017, the Board of Supervisors adopted an amended resolution for the Second Member of the Board of Retirement for the Los Angeles County Employees Retirement Association (LACERA) changing the term for this office to begin the day after the Board declares the results official (anticipated date September 12, 2017). The term for the Second Member Board of Investments has not changed. The General Members of LACERA elect these Board Members. To fill these positions, elections will be held this summer and will conclude on August 1, 2017.

General Members interested in becoming a candidate in these elections may obtain a nomination packet from the Registrar-Recorder/County Clerk, 12400 Imperial Highway, Norwalk, CA 90650, beginning April 24, 2017. Fifty signatures of active General Members who are General Members of LACERA on March 1, 2017, are required to qualify a candidate for each election. **Signed nominating petitions must be filed with the Registrar-Recorder/County Clerk no later than 5:00 p.m. on May 23, 2017.**

Any County employee who is a candidate in this election is a candidate in his or her personal capacity, and may not use County time or County resources to further his or her campaign. Any candidate who violates this provision, or has others violate this provision on behalf of his or her candidacy, is subject to discipline, including discharge from County employment. Any employee who violates these provisions is subject to discipline, including discharge from County employment.

The Registrar-Recorder/County Clerk will mail ballots via U.S. Mail to the mailing addresses of the eligible General Members beginning June 26, 2017. Eligible General Members who do not receive a ballot by July 7, 2017, and desire to vote or who have made a mistake on their original ballot and wish to correct it, shall notify their Department Election Coordinator on or before July 13, 2017, and explain in writing why a duplicate ballot is being requested. The Registrar-Recorder/County Clerk must receive the request by July 14, 2017. The Registrar-Recorder shall mail the requested duplicate ballot via U.S. Mail by July 18, 2017 to the mailing address supplied by members on the Request for Duplicate Election Ballot Form. **Ballots must be RECEIVED by the Registrar-Recorder/County Clerk by 5:00 p.m., August 1, 2017, to be eligible for counting.**
