On the first visit, advise a business of non-compliance and educate the
business on the importance of the health and safety protocols, and only
consider issuing a monetary fine for the most significant violations;

For businesses with a Public Health permit or license, focus on educating businesses on compliance and utilize permit suspension or revocation only for the most significant violations or for repeated uncured violations; and

Any other changes to current practices that will allow businesses acting in good faith to come into compliance and reopen safely.
