Entities must disclose all monetary and non-monetary campaign contributions of \$100 or more made during the period covered by the report to an elected County official, County candidate, a committee controlled by an elected official or County candidate, or a committee formed primarily to support such an official or candidate. This information is reported by lobbyist employers and covers the most recent four quarters. This report is updated quarterly.
